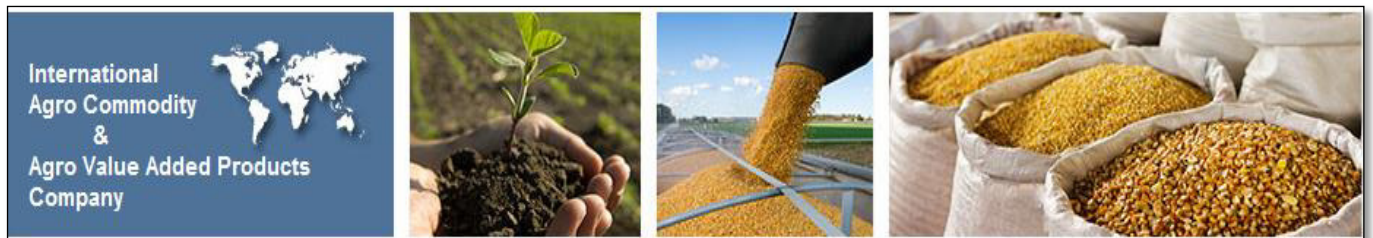

## Raw Cashew Nuts

---

Cashew nuts are the kidney-shaped seeds that adhere to the bottom of the cashew apple, the fruit of the cashew tree (*Anacardium occidentale*). The nut itself is protected by a very strong shell that needs to be roasted/steamed before it can be shelled. The edible part is the cashew nut kernel which is obtained after shelling. The kernel represents only around 20% of the whole cashew nut in weight.

Cashew nut kernels are produced by shelling raw cashew nuts (RCN), which grow at the end of cashew apples. Cashew nut kernels are primarily judged on their size, colour and moisture content.

We are exporter of raw cashew nuts sourced from the Ivory Coast, Benin, Guinea Bissau and Tanzania. The raw cashew nuts are procured directly from the farmers at their origin, where they undergo stringent quality control inspections before being transported to our processing warehouses to be dried and packaged for export to India and Vietnam.

Our investment in state-of-the-art drying facilities and world-class warehousing logistics ensures that high quality is uniform across every shipment.

## **Quality characteristics**

### **Raw cashew nuts:**

Quality of raw cashew nuts is determined by processing outturn, size of the nut, incidence of insect or fungal damage and moisture levels. Additionally, the ease with which cashew nuts can be shelled contributes to quality as well, difficult to shell cashew nuts lead to a higher level of nut kernel breakage.

There is not a general standard for cashew nuts but some parameters can establish the quality of the cashew and the appreciation on the market

#### 1 - Out-turn / Yield

It is the quantity of cashew kernel that can be obtained after decorticating (remove the shell of a cashew nut) 80 kg of raw cashew nuts. The count is in pounds per 80kg.

A good out turn is from 43 to 48 lbs

An excellent out turn is from 48 to 55 lbs

#### 2-. Nut count

It is the number of raw cashew nuts per kg

170 excellent

180-190 very good

190-200 good

200-210 middle

210-220 low middle

230 limit acceptable

Lower : poor

Please note that:

- It is necessary to balance this information with the out-turn
- In Africa most of the raw cashew nuts, depending the year, have a nut count from 190 to 210.

3- Moisture / Humidity

For export 12% and less otherwise there are risks for the goods during the shipping

4- Foreign matter 5% max

5- Defective Lower than 12%
